Dear Sir,

Here we are representing the matter which demand humane sensitivity and should only be dealt with humanitarian compassion and care, which we believe the authority been approached through this communication do have in abundance. All officers who are coming to Kerala from Karnataka Circle on Rule 8 Transfer , had applied for the same some 5 or 6 years back itself , due to various administrative and operative constrains this been delayed till now and hence have completed over 7 or 8 years in Karnataka circle. Most of the people were serving in remote areas, many times in hilly and tenure places across Karnataka Circle. The applications for Rule 8 transfer request were forwarded by these officer with the prospect of getting posting in their native places in Kerala Circle. Officers are eligible for Rule 8 transfer after the completion of 2 years continuous service in one Circle and in many other circle except Karnataka officer did managed to get transfer to their native around time duration of 2 years , but these unfortunate officer are getting transfer only after 7or 8 years in service due to various administrative reasons. For sole reason mentioned above these officers deserve due priority and sympathy. But it is a cause for worry and bemusement, as such no consideration were awarded to these officers while issued posting order in Kerala Circle via letter no NO.ST-III/2-11/R-8/2008/VOL III dated at TVM the 07/11/09 . Even the requests under spouse cases were not considered, which should have been considered according to the directions issued via letter no. 5-21/2009-Pers-IV Dated Feb 13th 2009. All these officers have very young families and relying on your prudence and deliverance to rekindle their family life.

So we request you, Sir to review these cases (Lists attached as enclosure -I) and issue immediate orders favoring these officers.
