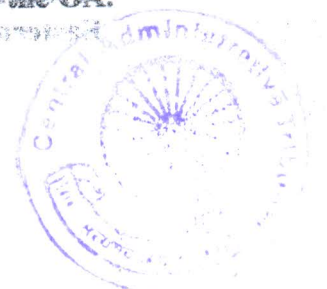

ORDER

The Hon'ble Bench has issued the following order:

"MA No.289 of 2011 is filed by the applicants to issue an interim stay of all further proceedings consequent to the DPC like transfer of SDE, in lieu of order passed by Assistant General Manager(Personnel II), Corporate Office bearing Ref No.2-15/200-Pers.II dated 30.3.2011 and further stay the order passed by Assistant General Manager(Personnel II), Corporate Office, bearing Ref No.2-15/2001-Pers.II dated 31.3.2011 until the pendency of the OA.



Heard the learned counsel for both sides and perused the records.

It is represented by the learned counsel for the applicants that the respondents are not following the roster system in making promotion to the post of SDE(T) from JTO. Per contra, learned counsel for the official respondents submitted that they are following the roster system with regard to the said promotions also. However, in the interest of justice, we are directing the respondents' counsel to produce the roster for promotion from JTO to SDE(T) consequent to the DPC, on the next date of hearing. Till then, the respondents are directed to maintain status quo with regard to the promotion from JTO to SDE(T). Call on 3.6.2011."
